Contract for Limousine Service

Agreement:

1. Big D's Limousine agrees to provide a limousine and chauffeur at the time, date and location specified on contract (additional hours upon availability).
2. Number of passengers allowed in the vehicle shall be no more than specified number in contract or limited to the vehicle passenger capacity it is designed to carry.
3. Big D's Limousine reserves the right to substitute a vehicle of equal or greater value in the event of mechanical difficulties or scheduling reasons.
4. I understand that Big D's Limousine and/or employees of Big D's Limousine may not be held responsible for items left unattended in vehicles.
5. I understand that the sale or use of ILLEGAL DRUGS, smoking in the vehicles or the use of intoxicants by minors is strictly forbidden in vehicles provided by Big D's Limousine. There will be no standing out of moon-roofs or hanging out windows. No firearms in the vehicle. Big D's Limousine reserves the right to immediately terminate service without any refund to any party or person(s) who violates these rule.
6. Big D's Limousine is not responsible for delays caused by weather, traffic conditions, mechanical problems, airlines and/or airport problems, automobile accidents caused by others or acts of God.
7. Customer may not attach or affix anything to the interior or the exterior of the vehicle(s).
8. Customer accepts full responsibility for vehicle damage or special cleaning, and any loss of Income due to negligence or carelessness caused by any member of my group, or myself (examples: vehicle damages caused from smoking, burns, vomiting, scratches, broken glassware, stains, wrestling in vehicles, kicking windows/mirrors, and etc..) and authorizes company to charge for the expenses regardless and in addition to any prior understandings and agreements. \$5.00 Fee per broken and/or missing glassware.
9. NO FOOD IN VEHICLE(S). \$200.00 CLEANING FEE WILL BE ADDED FOR VIOLATIONS.
10. DEPOSITS COLLECTED ARE NON-REFUNDABLE.
11. BIG D'S LIMOUSINE MAY VOID CONTRACT AND REMOVE RESERVATION IF RATES. GRATUITY AND/OR BALANCE DUE ARE MODIFIED BY THE CUSTOMER.
12. CHAUFFEUR GRATUITY 18% MINIMUM ADDED OR 20% FOR SPECIALS, HOLIDAYS AND HOURLY RATES THAT HAVE BEEN REDUCED TO THE MINIMUM CHARGE.
13. ANY BREACH OF THIS CONTRACT WILL RESULT IN TERMINATION OF SERVICE, REQUIRING BALANCE DUE IN FULL WITH NO REFUND.
